# **Understanding the Need**

Today, there are hundreds of women in the Portland, Oregon area who have experienced homelessness, incarceration, addiction and abuse who desperately want to re-engage in society in productive ways. But they are blocked.

These women find themselves with few employment options because of their background. Employers are often unable to hire women who have felonies, who were incarcerated, or who have gaps in their employment, like most of these women have experienced.

The result is this cycle is perpetuated.

Women who have been through a recovery program, like that of a rescue mission, have often left their problems behind them. But the mission's programs can only take them so far. They still need a bridge in order to get back to a productive, sustainable life.

We must give these women that bridge back to hope. This bridge is about helping women gain sustainable employment, which will allow them to return to a productive life. A real chance. Real change. Real hope.

Omega is that bridge. It is the bridge back to employment and productivity. It is the bridge back to a hope filled future. It is the bridge back to the community.

Omega is the bridge that provides these women with credible work experience because women need:

	Marketable skills - an opportunity to learn all aspects of the coffee business can
	help them obtain and keep long-term employment.
	A track record – we give them job experience that demonstrates their
	commitment to a stable, responsible life.
	<b>Training</b> – we provide a combination of work experience, coaching, mentoring, and community to help them over the hurdles that exist and give them hope for their future.
Omeg	ga differs from other programs because we:
<u> </u>	Work with women side-by-side, coaching to each individual woman's strengths.  Work with women who have completed a full rehab program but would otherwise have no realistic options for employment.

Employers seldom provide the accountability these women really need to succeed. Omega does! If they get out into the workforce too early, they may unnecessarily struggle. We are that safe place where they can grow and transform. We're that bridge to success.

# What Does this Bridge Look Like?

Omega provides a three-phase, up to 30-week paid internship program with a partnering business. Each internship requires a signed three-phase progressive agreement of each individual intern's goals. These goals focus on attendance, communication, and work skills. The Omega coach/mentor goes over each category with the intern before the first ten-week internship begins.

ine	coach/mentor also signs an agreement which includes:
	Providing one-on-one coaching/mentoring 1 hour a week
	Help with communication between intern and partnering business when needed
	Availability through the week for additional mentoring.

# Phases of Internship Program

**Phase One** – Includes 3 requirements:

- 1. **Attendance:** The intern will maintain respectful and professional 10-week attendance by being on time and committing to each scheduled day of work. Tardiness and or absences must be communicated to the business manager and Omega's staff via call or text.
- 2. **Communication:** The intern will maintain open and growing communication with Omega, Staffing Agency, and Partnering Business.
- 3. **Work Skills:** The intern will follow directions, accept feedback, and make changes as needed. She will communicate concerns and/or questions and will fill out timecards to track working hours with accuracy and submit to the Staffing Agency.

**Phase Two** – An additional 10-week internship upon successfully completing Phase One and decided upon by the partnering business owner, Omega coach/mentor and intern. It will include all of the requirements in Phase One, with the addition of measurable personal goals for development in work and life skills.

**Phase Three** – The concluding 10-week internship upon successfully completing Phase Two. Phase Three allows the intern and mentor to expand personal goals, including spiritual and financial goals. In this phase the intern will dig deeper and become even better prepared for re-entry into the workforce outside of the Omega program.
